Note: It is brought to your notice that while determining the permissibility of the posts as per Government Decision dated 3.11.2018, the said grantable posts are not final as the review of the posts has not been finalized.

- 1. The present workload is calculated taking into consideration the aided faculties/departments/subjects functioning in the college and the number of students admitted.
  - 2. It is mandatory to register the post in the actual college of the faculty/unit/subject mentioned in the proposal submitted by the college for placement and the number of students certified by the university.
- 3. Mandatory number of students for grant and maximum number of students for workload calculation should be taken into consideration.
- 4. The batch of number of students prescribed as per the government rules will be mandatory for the demonstration.
- 5. The hours mentioned for training/demonstration/tutorial, project work must be as per the rules prescribed by the government.
- 6. According to the post sanctioned to the college, the reservation point is nominated through the prescribed authority as per the prevailing reservation policy of the government must be certified.
- 7. The sanctioned number of posts will be reduced in the next academic year if there is a decrease in the number of students or if the workload of the aided department decreases due to other reasons.
- 8. As per the prevailing policy of the Government as per the sanctioned post no appointment shall be made without the prior permission of the Government. If any irregularity is found in the appointments to such sanctioned post, the grant will be disallowed in determining the grant. Irregular appointment will be the responsibility of concerned management and college.

9. The grant-eligible posts of the college have been subsidized on the basis of workload. It is necessary to obtain a No Objection Certificate by submitting a proposal separately as per the prevailing policy and procedure of the Government for the recruitment of posts on G.S. Pands
