1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Kala Mahavidyalaya Malkapur, Akola was started by the Indian Social and Research Foundation (Akola) in the year 2000. The college is situated in the heart of MIDC and more than 20 nearby villages. Industrial work (as a worker) and farming are the main profession of the people of this region. Before the establishment of this college, there was no other senior college in Malkapur, Akola. Students from laborers' and farmer's families were deprived from the opportunity of higher education. To give them the quality education for their better future is the main objective and determined goal of Indian Social and Research Foundation.

In 2000, College started with rented building with few numbers of students and now College has its own building with huge playground. Taking into consideration the need of modern education, the society started Bachelor of Computer Application in 2007-08, Bachelor of Journalism and Mass Communication, Post Gradate Diploma in Hospital Management, Computer Management, Retail Management in 2008-09, Bachelor in Fashion Designing, P.G. Diploma in Hardware & Net Working, Event Management, and Translation in Stenography in 2009-10. The co-ordination between teaching and non-teaching staff has helped a lot. Our team works hard to achieve aims and objectives of the college. The students of rural area as well as MIDC region are taught and guided by our young and enthusiastic teachers. Every institution has its own struggling past which is always witness by everyone. Just like a metal in the burning furnace our college too, has gone these stages to take a shape. When college was first started, it was in rented building in the outside area of Akola. People of this area were suffering from how to access Higher education. Our founder resolved to serve for those needy one. College built its own building in the area which is surrounded by MIDC and rural-slum area.

Vision

The vision of the college is "To provide the quality education for the development and better future of downtrodden, poor and needy one."

Mission

The mission of the college is 1) To provide quality higher education to its students. 2) To strive and provide education to poor, downtrodden and exploited community of this area who are refrained from the opportunity of higher education. 3) To create hope among the students of rural and MIDC area and motivate them to uplift their life. 4) The college takes an initiative for all round development of students coming from disadvantaged sections of the society and inculcates moral and human values in them through curricular, co- curricular and extra- curricular activities. 5) Attention is given to make the students assist themselves and contribute to the well-being of the society and the nation as well. 6) To take part in various national schemes like Dowry Demolition, Blood Donation etc. This is being translated through effective governance. The college management is headed by the Principal and is involved in coordinating the functions of the college to its logical end. Various committees comprising members of teaching and non-teaching faculty are involved in curricular and co-curricular affairs and administrative functions of the institution. The heads of the departments / subjects are authorised to monitor the routine functions at the departmental level. The administration encourages them and supports them at all levels. The decision taken by them are given due cognizance by the Principal. The

leadership qualities and decision making ability are nurtured in heads of Departments. An environment of equity and democracy is setup to conduct affairs in smooth and satisfactory manner.

Institutional Weakness

1) In spite of our sincere efforts in the class room teaching work, the examination results are not up to our satisfaction.

2) High dropout rate.

3) The teacher is the back bone of education of system. Unfortunately, since the introduction of the UG programs on non-grant basis like B.C.A., B. Sc. In Fashion Designing, B.A. In Journalism and Mass Communication and PG Diploma in various fields, we couldn't get regular teachers for these newly introduced programs which are permanent non grant basis. So we have to appoint contributory teachers for these programs. So it's adversely affecting the strength of the students.

4) As well as for the granted Bachelor Degree in Arts (B.A), we couldn't get regular faculties for some subjects and we appointed contributory teachers so it affects our result. Fortunately we appointed permanent faculties

for some subjects in current session.

- 5) Inadequate e-resources.
- 6) Publications in national and international journals not satisfactory.
- 7) Insufficient infrastructure.
- 8) Insufficient books/ periodical/ journal/ reference books in library.
- 9) Low attendance of students.
- 10) Insufficient number of teaching faculty and non-teaching staff.

Institutional Opportunity

) Most of the students are from rural background to which higher education is the most essential to build secure future and social mobility.

2) Opportunity to restart employment oriented vocational and professional courses.

3) The college proposes to start pre –coaching classes for competitive examinations.

Institutional Challenge

3) Increasing number of colleges permitted by the government may decrease the admission of the old colleges and cause a lot of harm to the teachers working in these colleges.

4) Some courses are not working properly. To restart non aided course like B.C.A., B.A. in journalism and Mass Communication and PG Dimplomas.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

The institution has designed a proper planning for effective implementation of curricular activities. The college follows university syllabus and prospectus. The annual plan is worked out through the daily academic diary. The departmental meetings are conducted at regular intervals regarding planning and implementation of the syllabus as per the guidelines of IQAC. We follow the system of syllabus completion, teaching plan, academic

diaries and periodic reports. Along with regular classes, the college organises special lectures by various experts for effective curriculum delivery. Feedback, suggestions and recommendations from the students, teachers, stakeholders and alumni are addressed to the competent authority. Periodical internal assessment like home assignments, class seminars, projects, unit tests, surprise tests, book review, etc. are conducted by the faculty members. The college offered some certificate courses in different subjects in the form of Add on Courses. Most of the faculty members have been giving their contribution in paper setting, moderation and valuation work of the university. Cross cutting issues relevant to gender equality, environment and sustainability, human values and professional ethics are integrated by our institution into the curriculum. Various units in the curriculum cover these mentioned topics. Since the college follows co-education pattern it is necessary to overcome the issue of gender discrimination. Women Empowerment Cell is constituted by the college for this purpose, Environment studies is a part of Curriculum. It is mandatory for the students of 2nd year to pass the concerning examination. Anniversary of national heroes, health awareness programs, tree plantation, blood donation, cleanliness drive, social work, etc cover the topics such as human values and professional ethics

Teaching-learning and Evaluation

The college has a continuous internal assessment mechanism to enhance the quality of learning experience. Student centric methods such as experimental learning, participative learning and problem-solving methodologies are used. Extra lectures, classroom interactions, continuous counseling sessions, coaching, personal guidance, study tour and problem-solving session are conducted for learners. Guest lectures and cultural programs are conducted. Modern ICT tools are used by the teachers effectively. Teachers prepare PPTs on syllabus and audio, video clips from internet are used for effective teaching. Class tests, unit tests are conducted. Home assignments, seminars, presentations, field works and excursions are arranged. Practical Examination, project work, viva-voce, poster competitions, exhibitions are conducted. The effective implementation of the evaluation and reform in CIE are carried out by the teachers. The college follows transparency in its internal assessment. Department Head monitors internal assessment. The examination committee sorts out grievances related to examination. The answer papers of examination are given back to the students for analysis and future reference. All the enrolled students of each current year are grouped in a list, class wise and year wise proportionate with the number of existing faculties in the college. The listed students are allotted to each of the faculty as a guardian of the said students to promote learning among them. The faculty functions as students' support in matters of academic enhancement. They meet, discuss, clarify and share various problems which may be sometimes personal, domestic, and mostly academic etc. The teacher involves local guardians i.e., parents as well, whenever necessary. The students are asked to share their e-mail id and mobile numbers with the teachers and their peers, so that a social network is established. Slow and Advance Learner, Mentor Mentee Scheme is activated to provide proper knowledge and encourage the students. Time Table committee, IQAC and the principal monitor implementation with its adherence to the academic calendar

Research, Innovations and Extension

The college has constituted internal academic research committee. It has been created a type of formal mechanism to establish a research culture. It functions as a system that encourages faculty members to enhance their teaching, research and administrative skills, as well as social services. Faculty members are encouraged to undergo professional development programmes and organize and participate in Conferences, Seminars and Workshops. Teaching and non-teaching staff are encouraged to enhance their qualifications and pursue Ph. D

programs. The institute has a well-defined and published research promotion policy. The main objectives of these research divisions are to contribute to the society through their research. The faculty publishes their research through a leading publication firm. As an instance the present research output of faculty comprises the research papers published through reputed journals and conference proceedings. The students' and staff's dedication towards extension activities which is for the betterment of society was highly appreciated by villagers and Gram Panchayat of these respective villages. The college has undertaken various programs to work on Swachh Bharat Abhiyan, HIV Test Camp, gender equality, Women Empowerment, Cleanliness Drive, Voter Awareness Program etc. A team of committed faculty members and various departments of the college engage students in community development programs such as social awareness program, environment awareness, eradication of plastic bags, blood checkup camps, yoga and meditation camps, literacy rally etc.

Infrastructure and Learning Resources

With a campus spread in 3.5 acre area, the college has building situated in MIDC Akola. The college is run by the parent society "Indian Social and Research Foundation Akola". The college provides and creates adequate learning resources and facilities. Updation and augmentation of infrastructure are done with the financial aid from the parent body as per requirement. Classrooms, administrative office along with principal's office and a Library are well equipped and furnished. ICT facilities with a computer lab are available as an additional teaching and learning facilities. We have 3 ICT- OHP installed Classroom. Excluding the office, the college has computers with Wi-Fi facility for academic use. The college has separate IQAC Cell. The college has a spacious playground with games and sports facilities. Ancillary facilities are provided for indoor games. The college library is partially automated. It has a learning facility with computer systems. Library has also Online Library Management Software. The college provides/allocates funds in its annual budget for procurement, upgradation and maintenance of ICT facilities. The college CDC is the topmost body constituted as per rules and regulations. Utmost importance is given to clean ship and maintenance of the class rooms, administrative building, toilets and the whole premises.

Student Support and Progression

To create more supportive academic atmosphere for students the support staff of administrative section are always at front. Students are provided with the scholarship facility sanctioned by the government. All types of applicable scholarships are introduced to the students and eligible students are given support to apply for such scholarships. Moreover, in the student progression to higher education and employment is promoted and the teaching staff is engaged to look after this aspect through various academic committees like career guidance and students counseling committee. The record of student appearing to PG degree course is also maintained by these committees. The college has formed various committees for welfare of students. Women empowerment cell, women redressal committee, career counseling and guidance committee, anti-ragging committee are working seriously in this direction through transparent mechanism. Many students get benefited through skill enhancement initiatives such as ICT computing skills, soft skills, language and communication skills, yoga, physical fitness, health and hygiene. Students actively support and offer their participation in organising and arranging different programs and also give their suggestions and demands to the concerning authority. Positive recommendations and suggestions proposed by the alumni are taken into consideration. Alumni also contributes and supports in successful organisation of various events such as blood checkup camp, health checkup camp, college annual function, tree plantation and other sports and cultural activities. As per the existing rules and regulations, government scholarships and free-ships are provided to the needy and eligible students. Concessions and scholarships as per government policies are given to the students. Many of our students are

highly benefited through the guidance provided to them about competitive exams by career counseling committee.. Many students aspiring to seek job in government or in other sectors are well placed in government or corporate or other sectors. The college has registered Alumni Association and it contributes in a various way to the college.

Governance, Leadership and Management

All the needs of the institution are looked after by the main bodies i.e., the governing body and CDC. These bodies monitor the details of meetings held and the decisions taken by the college development committee regarding finance, infrastructure, appointment, promotion of teaching and non-teaching staff, research and extension activities, etc. The issues concerning college development are frequently discussed by the management representatives during their visits. The institution provides various opportunities for overall growth of students to meet the vision and mission. Faculties have an active participation in major decisionmaking bodies like CDC/IQAC. There is a liberty for teaching and non-teaching staff members to share their suggestions and recommendations in staff council meetings. The decisions of the management are communicated to the staff by the principal. Head of every department is the root level observer having the authority to co-ordinate and to check the academic work. Each department takes its responsibility to assign teaching workload. Heads provide their support in overall academic works. Proper initiatives have been taken by the college to render quality to its various units. The perspective plans and policies are prepared. These plans and policies are based on the activities proposed by various departments for the calendar year

Institutional preparedness for NEP

1. Multidisciplinary/interdisciplinary:	The college is affiliated to Sant Gadge Baba Amravati University, Amravati where Academic programmes are redesigned to include Multidisciplinary /Interdisciplinary courses as electives and the college started offering these electives to students. From the session 2017-18, Semester Pattern has been implemented by the University. The CBCS pattern has been introduced from the session 2022-23 for the B.A. First Year students. In order to provide holistic academic growth among students, Inter-disciplinary curriculum has been proposed which gives freedom to the
	has been proposed which gives freedom to the student to choose their preferred options from the range of programmes offered by the institution. All

	the courses offered by the college are Choice Based Credit System (CBCS). A few of them also include value-based and environment-based subjects like professional Ethics, Environmental studies. All programmes are designed in such a way that students get maximum flexibility to choose elective courses offered by other Departments and MOOC through SWAYAM. It can be said that the college is proactively working towards the implementation of the suggestions given in the NEP 2020 Guidelines. In the line enhancing multidisciplinary approach, the college has adopted CBCS system offering courses through open ended, multiple exit and entry mode, in form of DSCs, AEC & GOEC courses from all the three disciplines such as Arts and Science. In Arts stream we have Marathi Literature, Marathi, English, English Literature, Urdu, Sanskrit, Political Science, Music, History, Economics and Home Economics.
2. Academic bank of credits (ABC):	Our college is affiliated to Sant Gadge Baba Amravati University, Amravati and bound to follow the courses, syllabus and other rules & regulations of the affiliating University. In the light of recent move under NEP 2020, the students are encouraged to enroll their names to attend online courses provided by open learning resource centers. As per university directives all students have opened their online ABC where their credits earned may get accumulated as online repository. Owing to the implementation of National Education Policy, the affiliating University has already taken initiatives to introduce Credit Based System at Under graduate and Post-Graduate level. The Academic Bank of Credits (ABC) would provide digital platform for the students for credit recognition, credit accumulation, credit transfers, and credit redemption. The initiative undertaken by the affiliating University is at preparatory phase. Therefore, it sequential for the institute to register for the ABC of each student
3. Skill development:	All the programs, social and environmental concerns, academic, employability, and personality development initiatives of the college are rooted in a holistic and integrated process of learning along with the curriculum under NEP. Real-life experiences related to rural life, professional development along with communication skills have been imparted through various innovative activities with the help of professionals in the concerned field. The various

	associations in the college keep good track of yearlong programmes for the holistic development of the students. During the admission time itself, students enlist their preferred and enrol in various certification programmes like NSS, Sports and Cultural activities they are interested in
4. Records are maintained by each department and information is provided to IQAC for documentation.

In the institute, in order to upgrade student knowledge a system of continuous evaluation and monitoring is used. It reduced the gap between learning and evaluation among the students. Periodic evaluation between semesters is essential to engage students in continuous learning. As a part of the curriculum, the University has made internal assessment mandatory for final year. For internal evaluation of First and second year, various tools such as home assignments, Unit tests, presentation skills, seminar and projects are conducted. Internal examination marks of final year subjects are filled and submitted through the Online Portal of the University by the Login Id of the concerned subject teachers.

The institution has Mechanism of internal assessment is transparent. The institution has an Internal Examination Committee which monitors examination and evaluation process. The committee directs the departments to conduct diagnostic test to identify slow and advance learner.
